The role of media propaganda to destroy the truth about the Rwandan genocide.

This message is sent to you by Projustitia Rwanda, on behalf of the people of the countries of the Great Lakes region of Africa and Rwanda in particular.

Media propaganda destroyed the truth about the Rwandan genocide and opened the door to lasting impunity for the crimes of the RPF. The latter is famous for being at the origin and perpetuation of violence in the Great Lakes region of Africa.

Propaganda and impunity act as paired forces of destabilization, often used by the authoritarian and bloodthirsty regime of Paul Kagame to control the population and conceal its own crimes. They erode the rule of law, manipulate public opinion and prevent justice for victims, thus creating a climate of insecurity, terror and abuse of power. The people of the Great Lakes region of Africa are tired of injustice, they are waiting for only one thing: peace and the end of impunity. The RPF took power in blood and violence. It is through the complicity of the UN, the will of the Clinton administration that the RPF was given power in Rwanda in 1994. It was therefore a political fact instead of a national consensus. This Rwandan genocide was then transformed into a Tutsi genocide in 2018. This is indeed observed in a briefing letter that the United States of America wrote warning against the transformation of the Rwandan genocide into a Tutsi genocide: the genocide against the Tutsis in Rwanda and they fail to grasp the full extent of the violence committed against other groups. Many Hutus and other people were also killed during the genocide, including those assassinated for their opposition to the atrocities committed. Not honoring and commemorating these victims gives an incomplete picture of this dark part of Rwanda's history.»* 1

The Rwandan genocide is the result of media and methodical propaganda, based on the arbitrary number of victims without any apparent reference of 800,000 to 1000,000 victims and tells us that the majority are Tutsis! A figure put into question since only 590,900 Tutsis were registered in the ONAPO population census*2 And by the way, the Ibuka survey of December 1995 shows 280,000 Tutsi victims*3 The total known number is 2,649,038 dead*4 excluding those in the RD Congo and elsewhere where an estimated 4,000,000 Hutu victims et Twa. The majority of victims are drowned, forgotten and omitted by will and political propaganda, the effective means used by planners to disorient public opinion. The big media of this world: CNN, BBC, TV5... they are aware of the terrible massacres triggered automatically after the downing of the presidential plane of Rwandan President Juvénal Habyarimana and announced the genocide without a reference base and



thus they influenced the sequence of events. The war that is proclaimed genocide but then imputed to a single community: (- Hutu) without taking into account all the actors (50,000 Interahamwe, 39,000 RPF infiltrators). At that point, the involvement of the international community was evident in the Rwandan war, so the international community took part in the politics of the RPF such that it reports its media using an opinion that is different from the truth based on surveys and serious research. If one admits that those who perpetrated the massacres are 50% Hutus and 50% Tutsis, the number of victims being 280,000 Tutsis and 4,000,000 Hutus, then the term Tutsi genocide would be easy and false because the one who triggered the Rwandan genocide is at the same time his planner*5 and he must therefore be held responsible and accountable. As the authors of these violences from the RPF camp have already enjoyed the impunity of the international community for a very long time, they have not been brought to justice as was the case with the authors of these violences from the Hutu camps.

Since the seizure of power in Kigali in July 1994 by the rebel troops of the RPF, Paul Kagame is de facto the real president of Rwanda, even if he was initially assigned the position of vice-president (he (Bizimungu Pasteur) who was president from July 19, 1994 to March 23, 2000), was a facade. According to the interview of Kizehe Raphael Verduumm Umunyamulenge, on Africa TV by Prof. Rutikanga*6. In its initial plan, the seizure of power in Kigali by the RPF was the creation of the Republic of Kivu and the building of a great Himalayan African empire, this project had been planned long before 1990*7; the main reason for the exportation of the war of conquest and domination, without taking into account the catastrophic human consequences that follow. From Uganda, the invasion of Rwanda on October 1, 1990 until today in the year 2026, the crimes committed by Tutsis criminals have never been prosecuted in justice and they do not care about anything. The infiltration of RPF soldiers and the recruitments are recognized by General Dallaire and Colonel Luc Marchal. The figures given by Lieutenant Nees, Madame Alison Des Forges and Abdul Ruzibiza vary between 4000 and 10000 men. While Tite Rutaremara, a very influential cadre of the RPF*8, talks about 5 people per cell. In total, they estimate 5 x 7,800 cells, or 39,000 people throughout the territory of Rwanda belonging to all political parties : MDR, MRND, PL, PSD, les jeunes du PL inkotanyi and TIP: Tutsi International Power. Etc. Paul Kagame and his rebellion have therefore taken power in violence, blood and tears; The worst part is that all this information was hidden from their superiors at the UN. This information would play a very important role in the judgments of the International Criminal Tribunal for Rwanda. This is one of the important missing elements that has turned the way towards the truth and the reconciliation of Rwandans, because the biased judgment of a single Rwandan community has resulted in permanent impunity in time and space.

Paul Kagame succeeded in perpetrating a political genocide, from which he derived his legitimacy, and he has used it to oppress his people for nearly 31 years. This genocide is not a national consensus; it is a political fact.. The genocide of 100 days, since the RPF introduced the ideology of genocide and its protective law n° 81/2013 of 09/11/2013*9 , it has become a biological genocide because all Hutu (Bantou) carry the gene of genocide in their blood. Paul Kagame uses a manufactured, durable and well-studied instrument to stigmatize and scare the Hutu community: the biological genocide or the Tutsi genocide and the ideology of genocide do not appear anywhere else in the Arusha peace negotiations that have lasted four years. The theory of the Tutsi genocide or the ideology of the genocide



was invented to justify that the genocide began on October 1, 1990, to say that Paul Kagame and the RPF do want to simply protect the criminals, at the same time placing their own crimes on the side of the victims from October 1, 1990 to December 31, 1994.

Kagame is a great manipulator for repeated crimes and aggressions in the countries of the Great Lakes region. He uses psychological strategies to influence others to his personal advantage, often in a dishonest manner, creating confusion, guilt or distorting reality, with narcissistic personality traits. In the first place, the manipulator Paul Kagame recognizes himself by tactics such as the reporting of responsibilities, unclear communication, denigration, disguised blackmail and displacement as a victim to obtain control. President Yoweri Kaguta Museveni's teacher and his student Paul Kagame forget that they are the real planners of the Rwandan genocide*¹⁰. In a television program, the correspondent Barore of Radio Rwanda gives an interview to Tito Rutaremara, who tells his story, he quotes: "We were preparing a war, we had infiltrated them, we had sent more than 149 cells only to Kigali. In Rwanda, we work in absolute secrecy. We sent 100, 200, 300 to those who were in the camps, and to the administrative cells, we sent 5 people by 5 people in each cell*¹¹. The suite of detail on the infiltration can be found in *The Rwandan Genocide: comprendre ses méandres et ses métastases*(understanding its complexities and metastases)*.¹²

Since July 13, 2007, the government of the RPF in Rwanda has taken the initiative to change the toponymy of the administrative entities in order to hide from the Rwandan population and the international community the truth about the places of its massacres against the Hutus. Thus he managed to make the well-known places of his massacres disappear, to occupy the lands of the disappeared or displaced populations, to be able to manipulate the population statistics without being discovered and in a more or less legal way*¹³. Since then, he has carried out systematic expropriations without compensation and carried out deadly hunts for the expropriated survivors of his killings, an injustice without a name and a macabre project to exterminate the Hutus and occupy their lands.

President Paul Kagame distorts reality: he ignores the evidence, minimizes your sentiments and questions your judgement. The recent example is the CNN international television interview conducted by M. Larry Madowo with Paul Kagame on February 3, 202. ... This journalist asks him if he can confirm that the Rwandan RDF forces are on Congolese soil? Kagame swears he knew nothing about it. A few days later on several TV and radio channels in Rwanda, he declared: "I will not give you Goma, Kivu and Bukavu, they are in my hands". Are there any other pieces of evidence expected? In short, the repeated announcements made by a Congolese, Corneille Nangaa and those of M23 also mean that they are prepared in Kigali!

The media propaganda to destroy the truth about the number of victims of the genocide started in Kigali on the memorials of this one. In Kigali, the genocide memorials record more than 300,000 deaths while the city had only 268,200 inhabitants, all populations combined in 1994 including 40,070 Tutsis. A flagrant and obvious inconsistency that shows that the term "Tutsi genocide" and the denial of the Hutu and Twa genocide are actually counter-truths. These genocide sites contain fewer Tutsi than more Hutu (280,000 Tutsi versus 4,000,000 Hutu). Let us recall that the Ibuka survey shows 280,000 Tutsi



victims*¹⁴ throughout the Rwandan territory. The real victims of the genocide: the Tutsis of the interior, the Hutu and the Twa who should have been the first beneficiaries of financial and political aid, they were apparently ignored or neglected.

The Rwandan government led by the RPF wanted to maximize the political gains and economic interests of the Rwandan genocide that turned into the Tutsi genocide, and blindly carried out this change without taking into account the remarks made by several UN member states including the United States, Great Britain and Japan*¹⁵. associations of the Tutsi community without exception à savoir: IBUKA, FARG, Agahozo, AVEGA, AERG, GAERG ... ; The associations of the Hutu and Twa communities have not been admitted to this ministry, fortunately or unfortunately, they do not exist within the country. The power establishes laws to consolidate the genocide and the funds to finance the benefits and acquisitions of the genocide and the ideology of the genocide as well as the wars that financially protect the power.

Let us look at to this date which announces that a genocide was committed around April 20, 1994 to relay the propaganda prepared by the American Administration of Clinton through Roger de Winter; Mrs. Albright; UK Lady Lynda Chalker; Belgium; Canada; Israel... The trigger of this genocide took place when the planners (Kaguta Museveni, Ugandan president and Kagame, Rwandan president) shot down the president's plane killing the presidents of Rwanda and Burundi: Juvénal Habyarimana and Cyprien Ntaryamira.

De facto Yoweri Kaguta Museveni is the leader of the war of expansion and conquest (of the Hima Tutsi Nilotic empire) to conquer the immense natural resources of the African Great Lakes region. Yoweri Kaguta Museveni and Paul Kagame are servants of the European imperialists. Museveni considers Rwanda as the 6th province of Uganda/Uganda, with reason since it was Yoweri Kaguta Museveni, the Ugandan president and his army who brought Paul Kagame to power in Kigali in July 1994. It is on the basis of his plan received from the imperialists that they acquired this power. This is because it is a strategic, economic and land expansionist war in the region of the African Great Lakes, especially in the DRC, whose mineral wealth is easy to sell on world markets via smuggling circuits and which contribute to financing the armed groups created by Rwanda and Uganda.

Kagame is a great manipulator, when he is accused of his rebellion every 5 years since 1996 or when he is in political trouble, he brandishes the card of the ideology of genocide and the card of genocide according to which the Hutus are carriers of the biological genocide, that they are waiting to exterminate the Tutsis, and yet the leaders of the FDLR, the leaders of the Interahamwe who are Hutus are in power in Kigali. Thus, this manipulation has become a tool of accusation in the eternal mirror.

Regarding the International Criminal Tribunal, the ICTR: it used truncated surveys, the result is small, it reveals that the accusation of the ICTR in 1995 is 93 people considered responsible for serious violations of international humanitarian law committed in Rwanda in 1994. These people are from the Hutu community only, the Tutsi members of the RPF have not been tried and worried until the closure of the Tribunal. Thus, the ICTR was a valuable instrument of the RPF to consolidate its power and it took advantage of it to enjoy impunity as long as possible.



If the ICTR had started a complete investigation on the entire Rwandan territory and if it had searched the bases of the departure of the RPF as the French anti-terrorist judge Jean Louis Bruguiere and as Car Del Ponte had wished before being relieved of his duties as President of the ICTR to know where the missiles that shot down the presidential plane came from, we would have been allowed to investigate the side of the rebels of the RPF and thus discover the location of the planning, the planners, the sponsors of the attack against President Habyarimana's plane and knowing the person responsible for the trigger of the Rwandan genocide.

The Rwandans intend to present to the UN Security Council a request to review the situation of two overlapping Rwandan genocides. The first genocide from January 1, 1994 to December 31, 1994, lasted 100 days or a year according to UN resolution 995 (November 8, 1994), which created the International Criminal Tribunal for Rwanda ICTR. And it tried only the Hutu community. The genocide of 100 days) recognized by the UN and the international community.

The second genocide was introduced by the RPF, the genocide from October 1, 1990 to December 31, 1994, and it became the genocide of 1550 days (5 years), since 1996 « Organic Law of August 30, 1996 on the organization of prosecutions of offenses constituting the crime of genocide or crimes against humanity, committed from October 1, 1990 to December 31, 1994 », the rebellion of APR/NRA fighters from Uganda who entered with weapons in hand massacred everything that was on their way, they want to wash away and cover up the crimes they committed during this period.

In its long-term project, the RPF went through the UN to accredit its thesis at the level of the international community. Thus, via the letter dated April 11, 2014, addressed to the Secretary General by the President of the Security Council resulting in the meeting of the Security Council which allowed the RPF to introduce the instruments of genocide and the ideology of genocide into the texts of the UN*¹⁵. It is from this meeting (S/2014/265) that the RPF concretized its project: the genocide from October 1, 1990 to December 31, 1994. The RPF claims from the UN that it entered Rwanda to stop the genocide while we know very well that the APR/NRA invaded Rwanda on October 1, 1990.

What does that mean?:- All the rebels of the RPF (APR/NRA) are victims of genocide, even those who had no family in Rwanda*¹⁶. If there was a genocide in this period from October 1, 1990 to April 6, 1994, it was that of Hutu, Tutsi and Twa. And by the way, the image of Kagame in Kishishe in RD Congo is exactly his image in Rwanda since October 1, 1990. This genocide that the RPF never mentioned during the Arusha Peace Accords (in Tanzania), which took place from June 8, 1992 to August 4, 1993. Rwandans need to know their true history, it is opportune to sort out the truth and rewrite the history of Rwanda.

Conclusion

To you, the media: If you have not been led into error by the RPF/NRA, if you are not complicit, you have the opportunity to save the Rwandan people by sympathizing with them and publishing the truth (it has been 31 years of lies and suffering under the bloody regime of Paul Kagame).



Ending the bloodshed that has been going on for more than 30 years and ending the impunity for the RPF crimes that continue in Rwanda and in the Great Lakes region also depends on the behavior of the media, especially the Western ones, by sufficiently denouncing this impunity and the violence in the African Great Lakes region.

Demand and obtain the opening of archives kept secret for a long time by the international community and the UN (USA, UK, France, Belgium, Israel, Uganda...) on wars in the countries of the Great Lakes region and genocides. These archives will help the people of the region and the whole world to know the truth about the planners and those responsible for the killing of the plane that transported the two presidents (Juvénal Habyarimana of Rwanda and Cyprien Ntaramira of Burundi).

- The truth will allow us to open an inclusive national dialogue between Rwandans, (DIRHI: Highly Inclusive Inter-Rwandan Dialogue) and acquire judicial prosecutions, disarming the RDF of this biological genocide that risks tearing the country and the region apart.

The Rwandan Democrats will rely on the Road Map's stake holders to correct the country's socio-political-economic situation, which is the inclusive political process.

Reconciliation is a political and social process aimed at restoring unity, peace and social cohesion after conflicts, political crises or historical traumas.

The rule of law and human rights are fundamental principles guaranteeing the supremacy of the right to equality before the law and respect for fundamental freedoms often used in legal and political contexts; development and shared prosperity.

It should be noted that President Paul Kagame is the most notorious and bloodthirsty dictatorial president the world has ever known, responsible for over 20 million deaths in Uganda, Burundi, Rwanda, and the Democratic Republic of Congo. He is a prime example of complacent impunity.

Rwandans need to know their true history, the media contribution is very useful to uncover the truth and rewrite the history of the Rwandan genocide.
